## **NON - CONFIDENTIAL FACTS AND ADVICE TO THE POLICE AND CRIME COMMISSIONER**

### **INTRODUCTION AND BACKGROUND**

In accordance with schedule 1 of the Police Reform and Social Responsibility Act 2011, before the Police and Crime Commissioner makes an appointment to the position of Deputy Police and Crime Commissioner, he must accept or reject the recommendation of West Midlands Police and Crime Panel as to whether or not the candidate should be appointed. The Panel met on 8 September 2014. As part of their proceedings a Confirmatory Hearing for the position of Deputy Police and Crime Commissioner was held. Councillor Yvonne Mosquito, the nominee of the Commissioner for the position, was in attendance and was questioned by the Panel in respect of her proposed role. In this connection, the Panel had been circulated with a copy of the criteria used by the Commissioner to determine his nomination, the proposed terms and conditions of appointment, Councillor Mosquito's declaration of her eligibility for appointment and a copy of her CV. A copy of the paper considered by the Panel is attached at **Annex A**.

On 10 September 2014, Councillor Darren Cooper, Chair of the Panel wrote to the Commissioner recommending that the appointment of Councillor Mosquito should proceed. A copy of the letter is attached at **Annex B**. I will notify the Panel of my decision to accept their recommendation as required by legislation.

### **FINANCIAL IMPLICATIONS**

The salary and expenses for the Deputy Police and Crime Commissioner are contained within the budget agreed by the Commissioner for his office..

### **LEGAL IMPLICATIONS**

Under section 18 of the Police Reform and Social Responsibility Act 2011 a Commissioner may appoint a person as deputy police and crime commissioner. Schedule 1 to the Act sets out the eligibility requirements and scrutiny requirements of appointments to such a post. This includes the requirement for a confirmatory hearing to be held of the proposed appointment by the police and crime panel for the police area.

### **EQUALITY IMPLICATIONS**

The Act specifically excludes section 7 of the Local Government and Housing Act 1989 which requires the appointment of staff on merit. However in making this appointment the Commissioner had regard to the needs of the diverse population who live and work in the West Midlands.
