Title: Changes to the Outstanding Citizen Award Scheme

EXECUTIVE SUMMARY

The Outstanding Citizen and Outstanding Young Citizen Award Scheme was introduced in 2013 to provide a means for the PCC to recognise people who have made an outstanding contribution to community safety in their community.

This decision updates the Scheme and introduces some changes. The most significant changes to the Scheme are as follows:

- 1. The number of award categories will be increased and will include:
 - Outstanding Citizen
 - Outstanding Young Citizen
 - Outstanding Community Project
 - Outstanding Community Initiatives Fund
- 2. Members of the Strategic Policing and Crime Board will be asked to work with their Local Policing and Crime Board to seek nominations for the awards.
- 3. Awards will be allocated by the Deputy Police and Crime Commissioner supported by the Assistant Police and Crime Commissioner.
- 4. Awards will be presented at an event in June 2015, which will be a joint event with the Custody Visitor Annual Meeting.

INTRODUCTION AND BACKGROUND

- 1.The Outstanding Citizen and Outstanding Young Citizen Award Scheme was introduced by PCC decision 034/2013. Local Policing and Crime Boards in each of the 7 local authority areas were asked to seek nominations and inform the PCC of their selected award winners. The PCC then attended a meeting or event in the Local Authority area in order to present the Award.
- 2. Whilst the awards were an excellent means of saying thank you to public spirited community members, in practice the take-up of the awards was limited, with only 3 of the Local Policing and Crime Boards selecting awards winners.
- 3. Some improvements to the Scheme have been introduced for 2015 in order to encourage more nominations and to have an Award Ceremony which appropriately recognises the contribution of the award winners. The revised Scheme is attached at the appendix.

FINANCIAL IMPLICATIONS

- 4. The resources required to plan and manage the revised Scheme shall be met from within the existing staff support resource of the Commissioner.
- 5. The costs of the award ceremony will be kept to a minimum by combining this event with the Custody Visitor Annual Meeting. The costs of the combined event have not yet been finalised but are likely to be in the region of £2000.
