Thank you for your freedom of information request received in this office on **14 February 2025** 2024 in which you asked:

‘For 2024, please provide, by month, how many:

1. Offences recorded
2. Arrests without charge/Not yet assigned an outcome
3. Charged/summons
4. Convictions and outcomes

For malicious communications.

Of these how many were also on suspicion of distributing, showing or playing a recording of acts intended to stir up racial hatred and what were the perceived targeted religions?

Of these, how many included instances of arson of religious texts, specifically:

- a. Sikh Religious texts
- b. Islamic religious texts (the Qu’ran)
- c. Christian religious texts
- d. Jewish religious texts such as the Torah

Of these, how many of these were malicious communications on social media platforms.’

Freedom of Information Right of Appeal

All requests for review will be recorded. Receipt of a request for internal review will be acknowledged and the appellant informed of an estimated date for determining the outcome. The OPCC will attempt to respond to internal reviews as soon as practicable and in any case within two months.

All investigations will be undertaken by someone not involved in the original response.

The result of any internal review will be communicated to the appellant outlining the decisions taken.
