

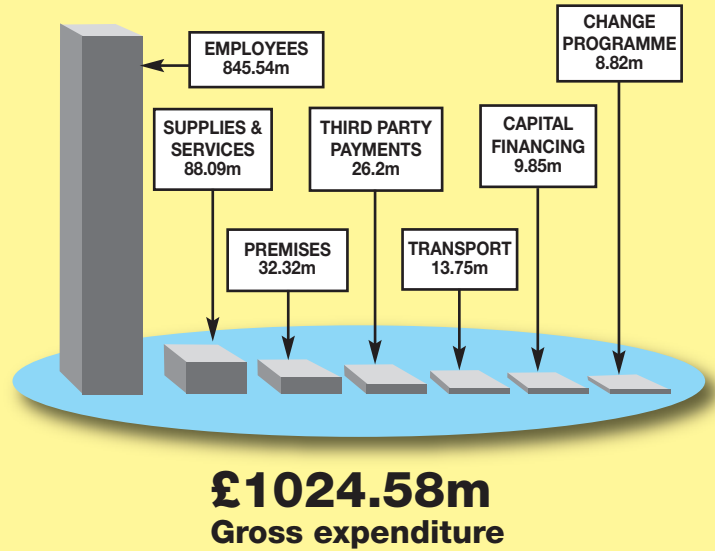


The tables below show how the net budget of the West Midlands Police and Crime Commissioner (£860.59m) is funded from Central Government, business payers and the precept on council taxpayers. This is compared with the previous year (£835.32m) with the main changes shown separately below.

This year I will be investing a record £187.8 million into policing for the West Midlands. The total net revenue budget for West Midlands Police, including national police grant, will amount to £860.6 million. As your democratically elected Police and Crime Commissioner, my duty is to secure the maintenance of the police force

and secure that it is efficient and effective.

In return for that investment, I will be holding West Midlands Police to account and working with the Acting Chief Constable, to ensure the Force does all within its power, to prevent and tackle crime, promote community safety and keep the people of the West Midlands safe and secure.

This investment will enable WMP to maintain police officer numbers during 26/27 and fund the police officer pay award for last year. That is welcome. However, the West Midlands Police budget remains under severe pressure.

For far too long, central government has failed to provide the police officers and investment that West Midlands Police needs. That is why we still have 520 fewer police officers and 500 fewer PCSOs than in 2010, while forces in other, lower crime parts of the country, have more police officers than ever before in their history.

We also have a national police funding formula, that is unfit for purpose and disproportionately disadvantages West

Midlands Police. I am committed to doing all within my power to ensure that our police force has the investment and resources it needs, to prevent and tackle crime, promote community safety and keep the people of the West Midlands safe and secure.

This year's settlement includes the opportunity for PCC's to raise their police precept by up to £15.00 per annum per Band D property in 26/27 – an amount that equates to £1.25 per month.

It is important to understand, the government's funding settlement assumes that every Force will increase its precept, in accordance with the maximum flexibility. The precept in the West Midlands is the second lowest in the country at £229.50. It will remain the second lowest, following the rise in precept, at £244.50.

I would rather the government had fully funded this increase, rather than effectively mandating it and imposing the burden onto local taxpayers. However, I was elected on a clear mandate to continue to re-build community policing and that is exactly what I am doing. People want accessible, reassuring and visible policing, out on the streets, keeping people, families, businesses and local communities safe and secure.

I am committed to doing all within my power, to ensure that West Midlands Police has the investment and resources it needs to prevent and tackle crime, promote community safety and keep the people and communities of the West Midlands safe and secure.
