Dear FOI Applicant,

Thank you for your freedom of information request received in this office on **24 February** 2026 in which you asked:

*'For the Aston Villa vs Maccabi Tel Aviv match in November 2025 battlefield drone jamming technology (RF + GNSS) was deployed to Villa Park, WMP put out a NOTAM to warn aircraft of jamming technology being deployed, however, the same equipment poses a risk to civilian infrastructure including equipment in hospital ICUs. Also this equipment is very expensive and NPCC have already confirmed they have no record of WMP reaching out for mutual aid to borrow such technology, suggesting the local taxpayers have picked up the cost of the hardware.*

All requests for review will be recorded. Receipt of a request for internal review will be acknowledged and the appellant informed of an estimated date for determining the outcome. The OPCC will attempt to respond to internal reviews as soon as practicable and in any case within two months.

All investigations will be undertaken by someone not involved in the original response.

The result of any internal review will be communicated to the appellant outlining the decisions taken.
